Education and Experience:

Billy Che Quintana earned his Master of Traditional Chinese Medicine from the Colorado School of Traditional Chinese Medicine in Denver, Colorado on December 21, 2013. This 3 to 4 year program included 2850 hours of course work in traditional Chinese medicine and western allopathic medicine, 615 hours of practicing in the student acupuncture clinic, and 180 hours practicing in the student internal medicine herbal clinic. After certification in Clean Needle Technique, he was certified as a Diplomat in Oriental Medicine by the National Certification Commission for Acupuncture and Oriental Medicine (NCCAOM) in 2014 . He also has continuing education in cosmetic acupuncture from the Center for Rejuvenation Acupuncture LLC.

Billy's therapy modalities include traditional Chinese acupuncture, cosmetic acupuncture, esoteric acupuncture, as well as the adjunctive therapies of moxibustion, tui na, cupping, auricular therapy, dietary and lifestyle recommendations, and traditional Chinese herbal therapy.

Billy is a member of the Acupuncture Association of Colorado and a registered acupuncturist in the state of Colorado. His license has never been suspended or revoked.

 10 treatments(2 treatments/week for 5weeks)\$1500
 -includes a package of home skin care products (valued at \$300)

All of the Services and Prices may include Tui Na (Traditional Therapeutic Chinese Massage), Cupping, Maxibustion, Chinese Auricular Therapy, and UVB or TDP lamp therapy when deemed appropriate by the practitioner.

All of the above costs do not include the price of any herbal teas or other products unless already stated.
